REGULAR TOWN COUNCIL MEETINGS - Town Council meets on the third Monday of each month at 7 pm in Council Chambers at Town Hall located at 30 South Main Street. Monthly workshops are held on the second Tuesday at 6 pm, also in Council Chambers. Additional meetings are scheduled as needed.

Town Council meetings may include **PUBLIC HEARINGS** on certain specific matters. If you wish to speak during a matter-specific public hearing you must sign up at the beginning of the meeting and you will be called on at the time that the public hearing is opened. Comments must be made from the podium.

A portion of each regularly scheduled Town Council meeting is set aside to hear **GENERAL PUBLIC COMMENT**. General public comment is reserved for speaking on matters not addressed during a public hearing. In order to speak at general public comment you must sign up at the beginning of the meeting on the comment sign-in sheets and you will be called on to come forward and speak. All comments must be made from the podium so Council can hear you. Time limits are enforced so that Town Council has adequate time to hear and discuss the items on its agenda. Groups of citizens in attendance at the meeting with the same or similar concerns are encouraged to designate a representative to speak on behalf of the group. In order to get through its agenda Town Council and Town Staff do not typically respond to general public comments made at the meeting; however, all comments received are recorded.

If you wish to correspond or submit a citizen comment in writing you are encouraged to do so and can use the **CITIZEN COMMENT FORM** on the back for that purpose. Written comments can be mailed to or dropped off at Town Hall, or emailed to Town officials or staff (see above).
